

THE BACKGROUND

Bribery, corruption, nepotism and other malfeasances have huge ramifications on any entity and organization leading most of the time to ineffectiveness and even to systemic failure because of the absence of controls and accountability.

For decades and to this day, there has been much hype, statistical data and a plethora of documentary evidence on corruption plaguing the Lebanese administration and putting the nation under the yoke of large budgetary deficits and lately leading to bankruptcy.

In the Lebanese public space, corruption is committed in several forms via public contracts and procurements, facilitation or "grease" payments, embezzlement of public funds, abuse of office, trading in influence and other suspicious acts.

Efforts of the Lebanese administration to fight corruption were of little or no avail. Results achieved so far provide ample evidence that measures were useless and ineffective in preventing fraud, and fall short of framing an offense against complicit public servants who should otherwise be criminalized under the Lebanese law.

Having said that, immediate attention should be given now to engaging a new mindset and caliber to fight fraud and corruption and create a momentum to implement concretely the recovery of stolen funds.



OUR VISION

1. TO EXPOSE & ENGAGE

We strongly believe that fighting local corruption and recovering stolen public money and assets should start and be triggered through legal actions initiated abroad and actively supported locally. Once this momentum is created, the process will be hard-to-stop locally.

Local Lebanese corruption authors along with their local and/or foreign accomplices ("their partners in crime") should be prosecuted in front of international panels and jurisdictions first.

Our approach is the only possible way to mitigate obvious conflicts of interests and bypass pressures exercised by Lebanese politicians on our local judicial institution.

WHAT IS CORRUPTION ?

GENERAL NATURE OF CORRUPT CONDUCT

Corrupt conduct is:

- a) Any conduct of any person (whether or not a public official) that adversely affects, or that could adversely affect, either directly or indirectly, the honest or impartial exercise of official functions by any public official, any group or body of public officials or any public authority, or
- b) Any conduct of a public official that constitutes or involves the dishonest or partial exercise of any of his or her official functions, or
- c) Any conduct of a public official or former public official that constitutes or involves a breach of public trust, or
- d) Any conduct of a public official or former public official that involves the misuse of information or material that he or she has acquired in the course of his or her official functions, whether or not for his or her benefit or for the benefit of any other person



- ▶ Matters of the same or a similar nature to any listed above.
- ► Any conspiracy or attempt in relation to any of the above.

- a) Collusive tendering
- b) Fraud in relation to applications for licenses, permits or other authorities under legislation designed to protect health and safety or the environment or designed to facilitate the management and commercial exploitation of resources
- c) Dishonestly obtaining or assisting in obtaining, or dishonestly benefiting from, the payment or application of public funds for private advantage or the disposition of public assets for private advantage
- d) Defrauding the public revenue
- e) Fraudulently obtaining or retaining employment or appointment as a public official
